Membership

I am happy to report that our membership is up from previous years. We had 68 members in 2015 and hope to continue growing.

Federal Documents Interest Group (FDIG)

The FDIG, chaired by Laura Saurs, continued its work to identify and discuss issues related to the preservation and access of federal information. Opportunities for continuing education and assistance were discussed, such as GPO's FDLP Coordinator Certificate, the FDLP Academy, and the FDLP Training Assistance Program. Practical concerns about individual resources and depository management were also discussed at length, providing members with a forum to share concerns, resources, and ideas. This year proved particularly exciting, however, as it saw two of our members participate in the Depository Library Council virtual meeting. Laura Saurs and Council Member Teri Taylor brought their expertise and enthusiasm to the *Public Library Depositories: Creating and Demonstrating Civic Value During Challenging Times* panel.

State Documents Interest Group (SDIG)

Deborah Mercer, Chair of the SDIG, brought a lot of great information to the group this year. The New Jersey State Library has digitized over 18000 state documents and Deborah was not only able to keep us updated on the content, but also demonstrate the repository's features.
