# DANJ Fall Conference Recap

DANJ held its annual conference for 2015, “Getting Down to Business in New Jersey: Government Resources and the Bottom Line” at Rider University on October 30, 2016. Author Jon Gertner delivered the keynote speech, “Making ‘the Idea Factory’: writing and Researching the History of Bell Labs,” which highlighted the role of archives in researching Gertner’s historical account of the history of innovation at Bell Labs.

Following the keynote speech was a full roster of informative and engaging educational speakers. Ronald Cook and Diane Campbell of Rider university spoke about “Using Government Information to Predict a Start-up’s Potential,” which featured both Federal and New Jersey resources available for entrepreneurs putting together a business plan. Andrew Hait of the U.S. Census Bureau presented an in-depth look at the “Census Business Builder: Small Business Edition”, the Census Bureau’s new visual data tool which tailors census data for small business owners. Capping off the day, Rutgers University’s Ka-Neng Au encouraged conference attendees to “Climb Every Mountain, Search High and Low,” a look at lesser-known government sources available for business research. # New Jersey Uniform Electronic Legal Material Act Update

The Uniform Electronic Legal Materials Act (UELMA) is a uniform law that deals with the publication of state law in electronic formats. The ease with which electronic records can be altered and the technical challenges associated with digital preservation have raised the question of whether electronic documents produced today will continue to be available to the public in the future. As states increasingly publish legal materials in electronic form in lieu of print, UELMA was designed to alleviate some of these uncertainties for this important category of state documents.

The National Conference of Commissioners on Uniform State Laws approved and recommended UELMA in 2011 (available at [http://www.uniformlaws.org/shared/docs/electronic%20legal%20material/uelma\\_final\\_2011.pdf](http://www.uniformlaws.org/shared/docs/electronic%20legal%20material/uelma_final_2011.pdf)). In 2012, DANJ took the position that UELMA should be adopted in New Jersey and urged New Jersey's Law Revision Commission to take action. Twelve states have already enacted the uniform law, and it is under consideration by the legislatures of an additional five states.

UELMA applies only to legal documents that are available exclusively in electronic format. Records trigger the requirements of UELMA only when published by an "official publisher," a designation that is left to the discretion of each individual state. If UELMA applies to a document, then the official publisher must meet four legal requirements: (1) the electronic record must be designated as official, (2) the document must be authenticated, (3) the document must be preserved, (4) the document must be made available for permanent public access.

New Jersey's version of the Uniform Electronic Legal Materials Act is still under consideration by the Law Revision Commission. The most recent draft, available at <http://www.lawrev.state.nj.us/UELMA/uelmaRDTR030716.pdf> was last discussed at the Commission's March 17, 2016 meeting.
