### Announcement

DANJ will be offering two grants to members of the New Jersey Government Documents community in the amount of 300 dollars each to offset the cost of travel to the Depository Library Council Meetings and FDLP Conference on October 16-18, 2017 in Arlington, VA. Details on how to apply for a grant will be posted on the DANJ website and mailing lists starting in mid-June.

### FDLP Regional Discard Policy

In fall of 2015, the Joint Committee on Printing approved a proposal of the Superintendent of Documents that would allow regional depositories to discard materials in their collections under certain circumstances. The policy requires that before any items may be discarded, those publications must be available in authenticated form on FDSys, that regionals obtain prior approval from the Superintendent of Documents, that regionals offer the items first to their selectives, then to the national needs and offers list, and that at least four tangible copies be available and "distributed geographically" throughout the country (https://www.fdlp.gov/news-and-events/2403-jcp-approves-regional-discard-policy).

While no regionals have as yet been permitted to discard any documents under the new policy, critics have pointed out a number of potential concerns with the planning and policy documents that have been released to date (<a href="https://www.fdlp.gov/news-and-events/2648-regional-discard-policy-informational-resources-virtual-discussion">https://www.fdlp.gov/news-and-events/2648-regional-discard-policy-informational-resources-virtual-discussion</a>). Those concerns include risk of loss of public access to material if copies in FDSys are damaged or inaccurate, and the lack of permanence of draft agreements with "preservation stewards" who would provide the geographically distributed copies of tangible documents (<a href="http://freegovinfo.info/node/11247">http://freegovinfo.info/node/11247</a>).

For those who may be wondering what the new policy will mean for New Jersey depositories, little is expected to change, at least in the short term. Laura Saurs, regional depository librarian at Newark Public Library, notes that of the 687 entries in the "Titles Eligible for Discard" (<a href="https://www.fdlp.gov/file-repository/about-the-fdlp/policies/superintendent-of-documents-public-policies/2742-regional-discard-eligible-titles-list-september-2016">https://www.fdlp.gov/file-repository/about-the-fdlp/policies/superintendent-of-documents-public-policies/2742-regional-discard-eligible-titles-list-september-2016</a>) most are congressional hearings, Federal Registers, and daily Congressional Records. Her immediate plans are to continue to maintain print and/or microform collections of these documents.
